b. Councilman Brian Yarnall asked Mr. Deal about the Sidewalk Loan Program. Mr. Deal stated the Homeowner can select the Contractor of their choice and the term of the loan for up to five years.

c. Councilman Tony Johnson updated Council on a recent Street-Alley-Sidewalk Committee Meeting regarding a one-way on Euclid Avenue. Mr. Johnson stated that the majority of residents on Euclid were in favor of making it a one-way. Mr. Johnson stated it is an issue. It is also an escape route to 800.
