	SECTION I

SECTION II

User shall provide to Village, its successors and assigns such easements as are necessary to construct, operate, inspect, repair, maintain, and replace a transmission pipeline and appurtenant facilities, and such other easements as are necessary to connect the transmission line to User's property describes above.

SECTION III

All construction and connections shall be to Village's specifications. The service line shall be properly connected to the metering system of the Village. Such connection shall be made only after prior approval is received from the Village for such connection. User shall be the owner of all equipment and material installed from the corporation stop except the service tap, meter and cut-off valve, which shall be owned by the Village.

SECTION IV

User agrees to pay a connection fee of \$	upon execution of this agreement. User
shall not be charged a meter deposit and no part of the o	connection fee shall be refunded after
discontinuation of service.	

Renter and those buying on land contract are required to pay a security deposit of \$175.00 for service. Such payment must be paid for in advance.

User agrees to pay for the water used at such rates, time and place as shall be dete	ermined by the			
Village including any penalties due and owing for non-compliance or late payment as set out in rules				
and regulations of the Village. User agrees to pay a tap fee of \$				
User shall also be responsible for all Village costs in excess of \$	_incurred in			
installing the tap or otherwise in connecting User's property to the transmission line.	The user shall			
connect his service lines to the Village's distribution system and shall commence to u	se water from			
the system on the date that water is made available to User by the Village.				

SECTION V

User agrees that the Village shall have the right to locate service tap as such location as it desires.

SECTION VI

In the event total water supply shall be insufficient to meet all the needs of the Users or in the event there is a shortage of water, the Village may pro-rate the water available among the various Users on such basis as is deemed equitable by the Village and may also prescribe a schedule of hours covering usage of water for garden purposes or other purposes by particular users and require adherence thereto or may prohibit the usage of water for such purposes. Further provided, if at any time the total water supply shall be insufficient to meet the needs of the Users, the Village must first satisfy all the needs of the User for domestic purposes and then supply any water for livestock purposes, lastly, supplying water for garden and other purposes.

SECTION VII

User further agrees to comply with the requirements of the Ohio EPA pertaining to back flow prevention and cross-connection control.

SECTION VIII

In addition to all other rights and remedies, the village shall have the right to terminate this Agreement for any failure of the user to comply with its terms, including non-payment of charges, and for other reasons set out in the village's Water Services Termination Policy. In such event, user shall not be entitled to receive, nor the village obligated to supply any water, and user shall be disconnected from the village water system. Prior to the resemption of services, user shall be required to pay all back charges, including penalties, construction costs, and the cost of damages to the village equipment, and shall also pay the reinstatement fee provided in the villages rules and regulations.

SECTION IX

In the event the User shall breach this agreement by refusing or failing, without just cause, to pay any charges due, service will be disconnected and shall not be reconnected until such time as all fees have been paid including any penalties incurred. Failure of a customer to pay all water charges duly imposed shall result in the automatic imposition of the following penalties:

- (1) User shall pay a ten (10) percent penalty if Monthly bill is paid after the due date.
- (2) If User fails to pay his bill within two (2) Weeks from the due date, the Village may In addition to other remedies, shut off User's water service.
- (3) Upon service being disconnected as stated herein, the reinstatement fee of \$70.00 will be charged for the re-connection of the service.

It is fully understood that the <u>sewer lateral</u> from the Village main line to the residence is the property of the homeowner and this line shall be maintained by such property owner and not by the Village of Barnesville Water Department.
