a. Roger Deal Village Administrator informed Council that the Rails to Trails & Tunnel Project is now estimated at almost 2.9 million. We originally committed to a 5% match of 2.1 million which was \$105,000. Council later discussed and approved \$66,000. They are now asking for \$100,000 with the escalated cost of the project, which is nearly 3.5%. A discussion was held. Councilmen Steven Hill and Brian Yarnall requested another meeting with ODOT for further discussion on the Project.

a. Mr. Deal "Thanked" the Park and Pool Crew for all their help with the Independence Day Celebration. The Park was well attended. The baseball games were a huge attraction along with the pickle ball tournament and tennis.

b. Mr. Hill stated the Theater Group put a lot of effort into putting on a concert at the Park and He was very disappointed that no one from Council or the Chamber attended. Councilman Tim McKelvey stated the Park stepped up and helped with the special lighting needed and He donated at the open house, and the fact that someone wasn't there doesn't mean they don't support it.

8 Water and Sewer

a. Mr. Deal gave Council an update on the Slope Creek Waterline Project.

b. Mr. Deal informed Council that the Water and Street Crew worked on repairing the 12" waterline on State Route 800 where the bridge is being replaced was struck by pile driving. There was no wire installed to locate it. It was 20 plus feet deep. They put 240' of pipe in clear away from the bridge and is now 6.5' deep where it should be with a tracer. Mr. Deal "Thanked" Roger Morris and his crew for all the excavation work. Mr. Deal expressed his appreciation to all the residents it affected, stating they were very pleasant to deal with and very understanding. Mr. McKelvey questioned the Contractor's responsibility in all of this and "Thanked" all the guys involved in correcting it.

c. Mr. Deal made mention to Council to look into water and sewer rates with consideration of a slight increase over a period of 3-5 years with the rising cost of materials and the Wastewater Treatment Plant Project in the near future. Mr. Hill and Mr. Yarnall expressed their rejection to any increase, while Mr. McKelvey stated it's something to keep in mind.

11 New Business

a. Somerset Township Trustees approached Council with concerns of South 16 Road conditions after the waterline project. Jamie Anderson, spokesperson for the Township Trustees expressed concerns about the Contractor not maintaining the road during the project and all the materials and time they had to put on the road during the project. Mr. Anderson made mention of the boat ramp and the extra traffic it creates. They feel now that the road part of the project is done that they should have dust control put back from the boat ramp to 800. Mr. Anderson stated they are not against the waterline or boat ramp that was put in, and also noted the Company did a good job other than maintaining the road. Their solution was to broom it off every night and that just wore our chip seal off. Councilman Mr. Hill asked the length of the road in concern and stated we want to be good neighbors. Mr. Yarnall asked what is the cost they are wanting that will take care of the problem.

Mr. Johnson made a motion, seconded by Mr. Hill to go half on chip and seal from the boat ramp to 800 for a cost of \$12,500 from the Village.
