Councilman Brian Yarnall explained to Council the HealthPlan renewal with increased deductibles after consideration and suggestions from a finance-Contract-Ordinance Committee Meeting along with our Representative from Schwendeman Agency, our Insurance Broker. The proposal will increase the deductibles to \$4,000/\$8,000 with Employees enrolled in the Single Plan to pay the front end amount of \$250 of the deductible and the back end of \$250, if applicable; Employees enrolled in the Family Plan to pay the front end amount of \$500 of the deductible and the back end of \$500, if applicable and the Village will pay \$3,500 deductible per Single Plan and \$7,000 deductible per Family Plan, if applicable. This could lower the 18.1% increased proposal from the HealthPlan renewal to a potential 3.71% increase. This proposal will increase Single Plan Premiums \$15.10 per month versus \$35.96 and increase Family Plan Premiums \$37.75 per month versus \$89.90 as proposed by the HealthPlan renewal with
