### Motion failed 2-4

Mr. Myser informed Council that the paperwork has been completed for the sale of property to Darren and Melissa Leach; and the sale of property to Neily Wilson.

Mr. Hill asked Mr. Michael Shaheen why He wanted the Bohandy Building. Mayor Hershberger and Council were given a letter of proposal from Mr. Shaheen for the purchase of the Bohandy Building this evening. Mr. Shaheen stated his Associate brought it to his attention and it is not unusual for him to be interested in commercial property. He stated it would be for multi use. A lengthy discussion was held. Mr. Joel Braido expressed his disappointment to Council with how they have handled his proposal and potential purchase of the Bohandy Building. Mr. Dave Ralston made a statement to the Mayor and Council. He commented on past and more recent involvements with Council. He suggested to Council to go back to an open and well publicized structure. Mr. Myser Village Solicitor made a statement to Council, We need to be brought back to the attention that whenever a Municipality owns a property you can not sell it privately, you have to sell it by public advertising and open bidding. Unless in a rare situation, and we have gotten off that rail, it should be put up for public auction and that is what the ORC dictates.

Mr. Yarnall made a motion that Mr. Myser prepare an Ordinance to transfer the property to the CIC so they can sell the property to Michael Shaheen for \$90,000.

Motion died on the floor as there was no second.

Mr. Hill expressed the need to discuss this kind of stuff in Executive Session and not public.

Mr. Shaheen commented that if Council is not taking any action this evening, could he have access to look at the Bohandy Building. Council approved.
