Protect yourself from phone, text and email scams

Impostor scams occur when a fraudster pretends to represent government institutions, private companies and charitable organizations. Be cautious of anyone seeking to confirm your personal information via phone, text or email.

Government impostor: A scammer might pose as a representative from a government agency such as the IRS, the Social Security Administration or a local court. They might demand payment for back taxes or an old court fee and threaten to arrest you if payment is not made immediately. The scammer might also request personal information, such as your Social Security number. Do not provide any information – hang up immediately.

Business impostor: A fraudster might contact you pretending to be from a well-known business. They might claim you've made a purchase that you didn't authorize and instruct you to call or follow a link to verify or dispute the purchase. If you're unsure whether the call is legitimate, look up the business's official phone number on its website and call the number directly. This scam might also involve fake notifications about undelivered packages.

Charitable scams: In this scam, someone pretends to be a charity and asks for a donation. Always inquire how much of your donation would actually go to the charity. Legitimate charitable organizations must register with the Ohio Attorney General's Office. You can verify a charity at https://charitable.ohioago.gov/Research-Charities. To ensure your donation goes to the right place, donate directly through the charity's official website or by calling a verified phone number. Be aware that scam charities often have similar sounding names to legitimate ones.

Ohio Turnpike Scam Alert

The Ohio Turnpike and Infrastructure Commission has reported a text message scam that fraudulently claims to represent tolling agencies across the country. Scammers request payment for unpaid tolls through fake websites. These messages are sent to random phone numbers, not tied to any specific account or toll road usage. Some recipients also reported receiving phishing emails. The Ohio Turnpike does not request E-ZPass payments via text, nor does it handle unpaid tolls through text messages. The only legitimate websites for Ohio Turnpike's E-ZPass accounts are ezpassoh.com and ohioturnpike.org. For questions about the Ohio Turnpike's E-ZPass notifications, contact www.ezpassoh.com or www.ohioturnpike.org.

The FBI, aware of these impostor scams in several states, recommends the following actions if you receive a fraudulent message:

Report the incident to the FBI's Internet Crime Complaint Center (IC3) at www.ic3.gov, and be sure to include:

The phone number from where the text originated. Contact the tolling agency's customer service center.

Delete any texts received.

If you clicked any link or provided your information, make efforts to secure your personal information and financial accounts and dispute any unfamiliar charges.

In general, here are some red-flag requests that should warn you of a potential impostor scam:

To wire money to a stranger or friend in need. To "act now!" To buy a prepaid money card. To send money in advance to secure or insure a loan. To provide personal information.

Consumers who believe they have been defrauded should immediately contact the company they used to make the payment. Ohioans can report scams to the Ohio Attorney General's Office at www.OhioProtects.org or by calling 800-282-0515.



60th Barnesville Pumpkin Festival - How It Started

Vernon Burkhart, a resident of Barnesville, Oh, started a small fair in the fall of 1964. It was held in the Assumption Catholic Church basement and was known as the Barnesville Fall Fair. Burkhart's inspiration for the event came from a trip through Tennessee with his wife in 1963 where they passed through a small town having a fall festival.

The Barnesville three-day fair attracted many people "offering the opportunity to see and enjoy the plentiful things that are grown on the beautiful acres of southeastern Ohio," including large gourds, many being pumpkins. The event, now a festival, became so popular that it had to be moved outside, still in the community on West Main Street in 1968. A board of directors was formed, and Burkhart served as the festival's first president. Many of the festival's contests and events were developed. The festival's first queen was crowned in 1968, the same year that the Barnesville Mother's Club added the "Little Miss and Mr. Pumpkin" contest, and the most popular "King Pumpkin" contest. The antique window display contest also began in 1968 and carnival rides were added in 1969.

Community involvement has been an integral part of the festival from the very beginning. At that first affair, Barnesville High Vo-Ag students served as judges as they do to this day, setting up early wide-spread community involvement in the festival. Early financial support came from local businesses and the invaluable support of the village government, which still exist.

In 1970, the name was changed to the Ohio Pumpkin Festival. That year also saw the festival's first street parade and the introduction of pumpkin ice cream, manufactured locally by Damsel's. This same year saw the first "King Pumpkin" display on Main Street. Expansions included a Banjo and Fiddle Contest, the Big Pumpkin Auction (1976), Pumpkin Run, (1977), and Pet Show (1980) among others.

By '80s the Wednesday night weighing of the giant pumpkins gained popularity and Saturday parade day crowds were estimated at 50,000. Still growing in popularity, the festival expanded its boundaries to the B & O Depot and Watt Center areas.

During its history, the festival has drawn its fair share of celebrities and brought national attention to Barnesville. Miss America 1971, Ohio's Laurie Lee Schafer was a special guest in 1974. The 150-member Ohio University Bobcat Marching Band livened up the 1974 parade. The Ohio State University Football Coach Woody Hays cut the ribbon in 1980 as did Ohio Department of Agriculture Director Harry Goldstein four years later. Also, in the '80s, the late Ed Johnson, host of the popular Agri-Country television show, broadcast from Barnesville and served as weigh master.

In 1999, the festival was featured on the NBC Today Show, The Discovery Channel and named as one of the top 100 Events in the United States by the American Bus Association.

In 2002, the name was changed to the Barnesville Pumpkin Festival. Attendance is now typically over 100,000 people for the four-day event.

The highlight of the festival is the "King Pumpkin" weigh-in, in which \$2.00 per pound is paid to the grower of the heaviest pumpkin. The Barnesville Pumpkin Festival still boasts the Ohio state record winning pumpkin, grown in 2017 by natives Todd and Donna Skinner and tipping the scale at 2,150 pounds, a far cry from the winning entry of then 12-year-old Thomas Rockwell in 1964, when the contest began. The Skinner's pumpkin helped them earn the 2017 Worldwide Great Pumpkin Commonwealth Grower of the Year title. The "King Pumpkin" is auctioned off on Saturday night, and the highest bidder takes custody of the pumpkin for 10 days, usually displaying it at their business. After that, the pumpkin is returned to the festival organizers, gutted, and its seeds are dried and packaged to be sold at the next year's festival.

To date, other festival activities include concessions, carnival rides, a queen pageant, pumpkin baby, little Miss and Mr. and mascot contests, a classic and antique car show, live entertainment on two stages, pumpkin pie baking and eating contests, pumpkin fudge contest, pumpkin rolling contest, horticulture displays, farm machinery display, tall tales, hog-calling, tobacco-spitting contest, beard and mustache contest, a pet contest, talent contest, banjo, fiddle and mandolin contest, a 5 K race, and a giant pumpkin parade



Barnesville Village Council is offering a loan program to residents in an effort to replace deteriorated sidewalks. The program offers zero percent loans to replace the walks that travel parallel with Village streets and will include curbs and driveway aprons. The village will select and pay the contractor and then send a monthly invoice to the property owner. All rules, regulations, and specifications of the village will be followed. Applicants must have not had any delinquent water bills over the past 24 months, unpaid Village Income taxes, or unpaid fines. The letter asks for those to send a gift amount. The Barnesville Police Department does not receive any money from this organization and have discovered other police agencies across the country are seeing this same scam. The Barnesville Police Department will never send a letter or call seeking donations or gifts. To the left is the scam letter that is circulating.

Ohio Outdoor Fire Laws: What You Need to Know

Ohio Revised Code 1503.18 Regarding Kindled Fires

O.R.C. 1503.18 is under the authority of the Ohio Division of Forestry.

This law prohibits outdoor open burning statewide in unincorporated areas during the months of March, April, May, October, and November between the hours of 6 a.m. and 6 p.m.

This ban includes burning of yard waste, trash, and debris, even in a proper burn barrel.

During spring, wildfire danger is high before plants have turned green, and in fall, fire danger is high due to abundant dry leaves and dead grass. Warm, windy weather in both seasons also contribute to elevated fire risk. Always be sure to use a proper burn barrel when burning outdoors during legal hours.

Ohio Administrative Code 3745.19 Regarding Outdoor Burning

O.A.C. 3745.19 is enforced by the Ohio EPA EPA notification is required for many types of open burns in Ohio.

EPA Basics for Homeowners

Materials NEVER to be burned at any time or any place in Ohio:

- Food Waste
- Dead Animals
- Materials containing rubber, grease, asphalt, or made from petroleum

OTHER RESTRICTIONS:

- Fires must be more than 1,000 feet from neighbor's inhabited building
- No burning when air pollution alert, warning, or emergency is in effect
- Fire/smoke cannot obscure visibility on roadway, railways, or airfields
- No waste generated off the premises may be burned
 No burning within village or city limits or restricted areas

VILLAGE OF BARNESVILLE PROPERTY MAINTENANCE CODE 1381

BUILDING MAINTENANCE: All buildings storage, houses, trailers should be weather resistant tight, free from excessive peeling or any deterorating conditions such as cracks, holes, broken glass that may admit rain, cold air, dampness, rodents, and insects.

FENCES OR RETAINING WALLS: Must be structurally sound and not deteriorating, must not have loose or leaning elements.

MAINTENANCE OF PREMESIS: Each and every premesis shall be kept free of all nuisances, health, safety, and fire hazards, unsanitary conditions, and infestation. It shall be the duty of the responsible party to keep the premesis free of said conditions and to promptly remove and abate the same.

TRASH, JUNK, DEBRIS: Such items are prohibitted

VEHICLES: Must have current & updated registration and tags. Must be equipped with all parts required to legally operate safetly on the roadway.

WEEDS OR HIGH GRASS: Cannot grow to a height greater than 12 inches on average, or any accumulation of dead weeds or grass cannot be exposed to public view.



JUNK &/OR INOPERABLE VEHICLES: Must be stored within a fully enclosed building or other location not exposed to public view, or shall be removed from the premesis.

The exterior of every premises and structure shall be maintained in good repair, to the end that the premises and each structure thereon will be preserved; adjoining properties protected from blighting influences; and safety and fire hazards eliminated

REPORT VIOLATIONS

Properties that are in violation of the Village Property Maintenance Code 1381 are given a notice to abate. This notice provides the property owner 30-days to correct the violation. After 30-days property owners will be summonsed to appear in Mayor's Court and may be penalized \$100 per day for each day the violation(s) continue after the abatement has expired.

Violations can be reported to the Barnesville Police Department at 740-425-1976, Barnesville Fire Department 740-425-3054, or you may report violations online by visiting www.barnesvilleohio.com and going to "Report A Concern."

As of August 30, 2024, the village has served or mailed 70 abatement notices for property issues so far. The Village continues to work on property maintenance violations.

Golf Cart Reminders

During the Summer months we tend to see an increase useage of Golf Cart Operations within the Village. We would like to remind residents of the rules/laws of operating golf carts within the Village of Barnesville **Corporation Limits:**



Schedule Inspection

- Call 740-425-1976 or stop into the Barnesville Police Department to pick up a Golf Cart Packet and/or to schedule inspection.
- Pay a \$50.00 Inspection Fee to the **Barnesville Police Department**

- Drivers/Operators of a golf cart must have a VALID driver's license.
- No person less than 16 years of age should operate a golf cart.
- No person shall operate a golf cart on the street within the Village of Barnesville unless the golf cart has been inspected.
- Do not drink and drive.
- Must obey ALL traffic laws during operation (No U-Turns).
- No person shall operate a golf cart on any public roadway that is 35 MPH or greater except when crossing such roadway. Crossing means from one side, directly to the other side. (Point A to Point B)
- Occupants of a golf cart should be seated at all times on the seat. Standing on the golf cart while in motion is prohibited.
- <u>ALL</u> occupants of the golf cart should be buckled up using a seat belt.
- Child safety seat is required for any occupant under the age of four (4) or under forty (40) pounds in weight.
- · Golf carts are not permitted to be driven on the sidewalk.
- Operation of a golf cart is permitted year round.



Barnesville PD Safety Pup Program



The Barnesville Police Department has teamed up with the Naitonal Child Safety Council in the Safety Pup Program. The program involves Preschoolers through Fourth grade. The program is funded through area business and private sponsers. Donations to this program help supply the kids with books, stickers, and other items to give out during program times. The program also helps obtain safety educational materials free of charge to the residents. The National Child Safety Council (NCSC) is the oldst and larges 501(c)(3) federally, tax-exempt, not-for-profit organization dedicated entirelly to the safety of children in the U.S. Over the years, NCSC has expanded its scope to include adults and seniors.

About NCSC

In 1955, after learning that more children in the U.S. die from accidents than all communicable diseases combined, Police Safety Service, as the Council was first known, was formed. By visiting police agencies and schools, ideas for mitigating this tragedy were explored. From this research, an effort to reduce the number of children dying from accidents through prevention education began. Police Safety Service was soon renamed to Child Safety Council and then later to National Child Safety Council (NCSC) as efforts expanded.

A law enforcement partner since 1955, NCSC is the only child safety organization with a network of safety coordinators working to support public safety agencies nationwide in their safety education efforts. These materials are distributed through community programs, events, and schools.

NCSC safety educational materials are used nationwide, NCSC is perhaps best known for the Missing Children Milk Carton Program it initiated and coordinated in the 1980s and 1990s. This program created unparalleled awareness of the child abduction issue worldwide.

Meet Safety Pup

Safetypup[®] was first introduced to the world on February 12, 1985, by NCSC founder H.R. Wilkinson, at a news conference in Washington, D.C., with award-winning actress Rita Moreno serving as a spokeswoman. Safety Pup was designed and developed by Jim Henson of Children's Television Workshop (Sesame Street, Muppets, etc.).

The conference was carried on CNN News, Good Morning America, and many others news stations and newspapers across the United States.

Safetypup[®] was created to make learning about safety issues fun, entertaining, and non-threatening. Today, Safetypup[®] is known by millions of children & adults from all over the U.S. and viewed as a trusted safety friend.



Safetypup[®] appears in NCSC safety awareness and prevention education programs and materials for law enforcement officers and teachers. This adds continuity to the programs and identity to the organization. Safetypup[®] is a registered trademark of NCSC.

Safetypup[®] has joined the ranks of many law enforcement agencies throughout the nation. Law officers have used their puppet versions of Safetypup[®] for presentations to children in hundreds of schools.
