**ORDINANCE NUMBER 3997**

**AN ORDINANCE TO AMEND BARNESVILLE  
CODIFIED ORDINANCE 1321.01(b)  
BUILDING PERMIT REQUIRED; FEE  
AND DECLARING AN EMERGENCY**

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BARNESVILLE, OHIO:**

Barnesville Codified Village Ordinance 1321.01(b), Building Permit Required; Fee, which currently reads as follows:

**1321.01 BUILDING PERMIT REQUIRED; FEE**

- (b) Consent shall be granted only upon majority vote of Council. If Council approves the application, the Clerk-Treasurer shall issue a permit evidencing such approval after receipt of a fee from the applicant. Such fee shall be calculated as follows: One percent (1%) of the cost of the improvement, but not less than ten dollars (\$10.00) nor more than two hundred fifty dollars (\$250.00). (Ord. 1908. Passed 10-4-93.)

**SHALL BE AND THE SAME IS HEREBY AMENDED TO READ AS FOLLOWS:**

**1321.01 BUILDING PERMIT REQUIRED; FEE**

- (b) Consent shall be granted only upon majority vote of Council. If Council approves the application, the Fiscal Officer shall issue a permit evidencing such approval after receipt of a fee from the applicant. **Such fee shall be a flat \$25.00 per permit.** (Ord. 1908. Passed 10-4-93.)

**FURTHER**, this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the residents of the Village of Barnesville. **PASSED** at a regular meeting of Council of the Village of Barnesville, held this \_\_\_\_\_ day of \_\_\_\_\_, 2024, by a vote of a majority of the members of Council.
