RESOLUTION NUMBER 3996

**A RESOLUTION AUTHORIZING THE VILLAGE OF BARNESVILLE
TO ENDORSE AND ADOPT THE SAFE ROUTES TO SCHOOL
TRAVEL PLAN FOR THE BARNESVILLE SCHOOL DISTRICT
AND SEEK STATE FUNDING FOR IMPLEMENTATION
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Barnesville is committed to improving safe, accessible transportation options for students in accordance with the goals of the Safe Routes to School (SRTS) Program, as authorized by the federal Safe, Accountable, Flexible, Efficient Transportation Equity Act (SAFETEA-LU) and continued through subsequent transportation infrastructure funding authorizing legislation; and

WHEREAS, SRTS funding is administered by the Ohio Department of Transportation (ODOT) and requires a formal adoption of a School Travel Plan to secure funds for project development, planning, and implementation; and

WHEREAS, the Barnesville School District and the Village of Barnesville have collaborated to create a Safe Routes to School Travel Plan designed to prioritize safety improvements for student pedestrians and cyclists, with the objective of building safer routes to schools and supporting active transportation; and

WHEREAS, the Village of Barnesville recognizes that the priorities outlined in the SRTS Travel Plan can help guide future ADA compliance efforts and address accessibility needs in a consistent and efficient manner.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Barnesville, State of Ohio that:

Section 1. The Safe Routes to School Travel Plan is hereby formally approved and endorsed by the Village of Barnesville.

Section 2: The Mayor, or an authorized designee, is empowered to submit applications for SRTS funding to ODOT, execute necessary agreements, and perform all acts necessary to secure funding for implementation of the approved priorities within the School Travel Plan.

Section 3: The Village of Barnesville recognizes that the priorities identified in the SRTS Travel Plan will serve as a preliminary framework for the Village of Barnesville's ADA Transition, with overlapping goals of improving accessibility and safety in public spaces.

Section 4: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety of the residents of the Village of Barnesville as it reflects the Village's desire to build safer routes to school and address accessibility needs.

ORDINANCE NUMBER #3987

**AN ORDINANCE TO AMEND BARNESVILLE
CODIFIED ORDINANCE 147.04 (PARK BOARD)
MEETINGS; OFFICERS; ATTENDANCE
AND DECLARING AN EMERGENCY**

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BARNESVILLE, OHIO:

Barnesville Codified Village Ordinance 147.04, pertaining to the Park Board, which currently reads as follows:

147.04 MEETINGS; OFFICERS; ATTENDANCE

The Board shall meet not less than monthly, at a time and place to be announced in advance. The Board shall organize by electing from its membership a President, Vice President, and Secretary. If any members shall fail to attend at least eighty percent (80%) of all Board meetings in any calendar year, this fact shall be reported to Council, who may remove said member in its discretion.

SHALL BE AND THE SAME IS HEREBY AMENDED TO READ AS FOLLOWS:

147.04 MEETINGS; OFFICERS; ATTENDANCE

The Board shall meet not less than **quarterly**, at a time and place to be announced in advance. The Board shall organize by electing from its membership a President, Vice President, and Secretary. If any members shall fail to attend at least eighty percent (80%) of all Board meetings in any calendar year, this fact shall be reported to Council, who may remove said member in its discretion.

FURTHER, this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the residents of the Village of Barnesville as it is necessary to provide clarification and guidance to the Park Board of the Village of Barnesville.
