And the Fiscal Officer is hereby authorized to draw her warrants on the Village Treasurer for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the Council as authorized by law to approve the same, and an ordinance or resolution of council to make the expenditures; provided that no warrants shall be drawn or paid from wages except to persons employed by authority of and in accordance with law or ordinance. Provided further, that appropriations for contingencies can only be expended upon appeal of two thirds vote of council for items of expense constituting a legal obligation against the village, and for purposes other than those covered by other specific appropriations made here.

This ordinance shall be deemed an emergency and is effective 01/01/2025.
