OPWC LOAN-STREET PAVING/IMPROVEMENT PROJECT

ORDINANCE NUMBER #4001

**AN ORDINANCE AMENDING CERTAIN EMPLOYMENT
PROVISIONS AS STATED UNDER CHAPTER 153 OF
THE BARNESVILLE CODIFIED ORDINANCES
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Barnesville Codified Ordinances currently addresses a Police Uniform Allowance under Chapter 153 in Ordinance No. 153.05.

WHEREAS, Ord. No. 153.05 reads as follows:

153.05 POLICE UNIFORM ALLOWANCE

- (a) At the beginning of the fiscal year, the Police Chief and each permanent police officer are entitled to a non-cumulative uniform allowance of six hundred dollars (\$600.00) per calendar year.
- (b) At the beginning of the fiscal year, part-time police officers, including a part-time Resource Officer, are entitled to a non-cumulative uniform allowance of two hundred dollars (\$200.00) per calendar year.
- (c) Upon hire, probationary police officers are entitled to a non-cumulative uniform allowance of three hundred dollars (\$300.00). After a probationary police officer is appointed by Mayor as a permanent police officer, an additional three hundred dollars (\$300.00) will be issued.

WHEREAS, the Village of Barnesville Codified Ordinances currently addresses a Clothing Allowance for certain Village employees under Chapter 153 in Ordinance No. 153.15.

WHEREAS, Ord. No. 153.15 reads as follows:

153.15 CLOTHING ALLOWANCE; POLICE UNIFORM ALLOWANCE

- (a) At the beginning of the Fiscal Year, the following employees will be granted an annual non-cumulative four hundred dollars (\$400.00) clothing allowance: Operations Manager, Full Time Employees in the Street, Cemetery, Water, and Sewer Departments, Park Director, and Water and Sewer Plan Operators.
- (b) In order to be entitled to a non-cumulative clothing allowance, an employee shall have been employed with the Village for at least six (6) months in a full-time capacity.

WHEREAS, the Village of Barnesville Codified Ordinances currently addresses a Clothing Allowance for EMS Department employees under Chapter 153 in Ordinance No. 153.18.

WHEREAS, Ord. No. 153.18 reads as follows:

153.18 EMS CLOTHING ALLOWANCE

- (a) EMS Department employees working a minimum of 188 hours per year shall be entitled to a uniform allowance of one hundred dollars (\$100.00). If an employee works in excess of 376 hours, then they will be entitled to an additional one hundred dollars (\$100.00).
- (b) The purpose of said clothing allowance is to assist eligible employees in purchasing all items of clothing which are usually and customarily worn when performing their duties on the Barnesville Emergency Medical Services.

WHEREAS, the Village Council has determined that the Village needs to increase the clothing and uniform allowances as stated above and amend the purchasing policy to reflect that as stated below.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Barnesville, Belmont County, Ohio, as follows:

Section 1: That Ord. No. 153.05 shall be amended and adopted to hereinafter reflect the following changes:

- (a) At the beginning of the fiscal year, the Police Chief and each permanent police officer are entitled to a non-cumulative uniform allowance of **eight hundred dollars (\$800.00)** per calendar year.
- (b) At the beginning of the fiscal year, part-time police officers, including a part-time Resource Officer, are entitled to a non-cumulative uniform allowance of two hundred dollars (\$200.00) per calendar year.
- (c) Upon hire, probationary police officers are entitled to a non-cumulative uniform allowance of three hundred dollars (\$300.00). After a probationary police officer is appointed by Mayor as a permanent police officer, an additional three hundred dollars (\$300.00) will be issued.

Section 2: That Ord. No. 153.15 shall be amended and adopted to hereinafter reflect the following changes:

- (a) At the beginning of the Fiscal Year, the following employees will be granted an annual non-cumulative **six hundred dollars (\$600.00)** clothing allowance:

Operations Manager, Full Time Employees in the Street, Cemetery, Water, and Sewer Departments, Park Director, and Water and Sewer Plan Operators.

- (b) In order to be entitled to a non-cumulative clothing allowance, an employee shall have been employed with the Village for at least six (6) months in a full-time capacity.

Section 3: That Ord. No. 153.18 shall be amended and adopted to hereinafter reflect the following changes:

- (a) EMS Department employees working a minimum of 188 hours per year shall be entitled to a uniform allowance of **two hundred dollars (\$200.00)**. If an employee works in excess of 376 hours, then they will be entitled to an additional **two hundred dollars (\$200.00)**.
- (b) The purpose of said clothing allowance is to assist eligible employees in purchasing all items of clothing which are usually and customarily worn when performing their duties on the Barnesville Emergency Medical Services.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety and this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
