A RESOLUTION TO AMEND AN AGREEMENT WITH CTI ENGINEERS, INC., TO PROVIDE SERVICES PERTAINING TO THE WASTEWATER TREATMENT PLANT IMPROVEMENTS PROJECT AND DECLARING AN EMERGENCY

WHEREAS, the Village of Barnesville desires CTI Engineers, Inc., to perform additional design, bidding, and construction administrative services not authorized in the original Agreement for Engineering Services, dated February 20, 2018, said services being related to the Barnesville Wastewater Treatment Plant Improvements project;

NOW THEREFORE BE IT RESOLVED by Council of the Village of Barnesville that:

- Section 1. The Village of Barnesville desires to enter into the Agreement for Engineering Services, Amendment No. 1, which is attached hereto as Exhibit A, to provide engineering services for the Village of Barnesville.
- Section 2. The Mayor of the Village of Barnesville is authorized to enter into the attached Agreement for Engineering Services, Amendment No. 1, with CTI Engineers, Inc.
- Section 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety of the residents of the Village of Barnesville regarding the Village's desire to continue to receive engineering services pertaining to the Village of Barnesville's Wastewater Treatment Plant Improvements project.

ORDINANCE NUMBER 4012

ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE VILLAGE OF BARNESVILLE, OHIO, TO EXECUTE A LEASE AGREEMENT SO AS TO LEASE THE PROPERTY KNOWN AS THE BARNESVILLE DEPOT TO BARNESVILLE AREA COMMUNITY FOUNDATION AND BARNESVILLE DEPOT COMMITTEE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Barnesville, Ohio, is the owner of certain real property and improvements, located at 300 E. Church Street, Barnesville, Ohio 43713, commonly known as the Barnesville Depot; and

WHEREAS, the above described real estate is not needed for any municipal purpose; and WHEREAS, the Village wishes to lease the parcel of real estate commonly known as the Barnesville Depot to the Barnesville Area Community Foundation as Lessee and the Barnesville Depot Committee as the Sublessee per the terms of the Lease Agreement attached hereto; and

WHEREAS, the Mayor of the Village be and he is hereby authorized, directed and empowered to sign the proposed Lease Agreement with the Barnesville Area Community Foundation and the Barnesville Depot Committee, and to execute all other instruments required to complete said transaction in accord with the Lease Agreement attached hereto.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BARNESVILLE, STATE OF OHIO:

Section 1. That the Mayor of the Village of Barnesville is directed and authorized to execute the Lease Agreement whereby the Village of Barnesville, Ohio, shall lease the property commonly known as the Barnesville Depot, located at 300 E. Church Street, Barnesville, Ohio 43713, to the Barnesville Area Community Foundation as Lessee and the Barnesville Depot Committee as the Sublessee; and

Section 2. That this Ordinance is declared to be an emergency measure necessary for the

immediate preservation of the public health, safety and welfare of the residents of the Village of Barnesville; and

Section 3. That this Ordinance shall take effect and be in force from and after the earliest
