A RESOLUTION TO AMEND AN AGREEMENT WITH CTI ENGINEERS, INC., TO PROVIDE SERVICES PERTAINING TO THE WASTEWATER TREATMENT PLANT IMPROVEMENTS PROJECT AND DECLARING AN EMERGENCY

WHEREAS, the Village of Barnesville desires CTI Engineers, Inc., to perform additional design, bidding, and construction administrative services not authorized in the original Agreement for Engineering Services, dated February 20, 2018, said services being related to the Barnesville Wastewater Treatment Plant Improvements project;

NOW THEREFORE BE IT RESOLVED by Council of the Village of Barnesville that:

- Section 1. The Village of Barnesville desires to enter into the Agreement for Engineering Services, Amendment No. 1, which is attached hereto as Exhibit A, to provide engineering services for the Village of Barnesville.
- Section 2. The Mayor of the Village of Barnesville is authorized to enter into the attached Agreement for Engineering Services, Amendment No. 1, with CTI Engineers, Inc.
- Section 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety of the residents of the Village of Barnesville regarding the Village's desire to continue to receive engineering services pertaining to the Village of Barnesville's Wastewater Treatment Plant Improvements project.
