**A RESOLUTION AUTHORIZING THE MAYOR OF THE VILLAGE OF BARNESVILLE TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE APPALACHIAN REGIONAL COMMISSION AND/OR OHIO GOVERNOR'S OFFICE OF APPALACHIA PROGRAMS AND TO EXECUTE CONTRACTS AS REQUIRED.**

**WHEREAS**, the Appalachian Regional Commission (ARC) and Ohio Governor's Office of Appalachia (GOA) provide financial assistance for equipment and capital improvements, and

**WHEREAS** The Village of Barnesville is planning to make capital improvements for the Barnesville North Waterline Extension project, and

**WHEREAS** the proposed improvement herein above described is considered to be a priority need for the community and is a qualified project under the ARC and GOA programs, and

**WHEREAS** the Village of Barnesville is requesting a grant from the ARC and/or GOA programs in the amount of \$250,000 for said project; and

**WHEREAS**, the Village of Barnesville has matching funds in the amount of \$5,261,147.18 from other grants, loans, and/or local funds for said project.

**NOW THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Barnesville:

**Section 1:** The Mayor of the Village of Barnesville is hereby authorized to apply to the ARC and/or GOA programs for funds as described above.

**Section 2:** The Mayor of the Village of Barnesville is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.
