**A RESOLUTION SUPPORTING THE OHIO COMMISSION
FOR THE UNITED STATES SEMIQUINCENTENNIAL (AMERICA250-OH)
AND DECLARING AN EMERGENCY**

WHEREAS, the Ohio legislature and the Governor created AMERICA250-OH in 2021 to plan, encourage, develop and coordinate the commemoration of the 250th anniversary of the United States and Ohio's integral role in that event and the role of its people on the nation's past, present and future; and

WHEREAS, AMERICA250-OH hopes to engage ALL Ohioans and ALL 88 counties through their many signatures and officially recognized programs, projects and events over the next several years by inspiring future leaders and celebrating all Ohioans' contributions to the nation over the last 250 years; and

WHEREAS, by adoption of AMERICA250-OH Resolution, we hope to educate, preserve, innovate, and celebrate.

NOW THEREFORE, BE IT RESOLVED by Council of the Village of Barnesville that:

- Section 1. The Village of Barnesville hereby endorses AMERICA250-OH and their mission to educate, preserve, innovate, and celebrate EVERY Ohioan in EVERY county.
- Section 2. A copy of this Resolution will be sent to the Municipal legislative delegation and AMERICA250-OH Commission.
- Section 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety of the residents of the Village of Barnesville in order to celebrate and coordinate the commemoration of the 250th anniversary of the United States.

RESOLUTION NUMBER 4037

**PROVIDING FOR THE EMPLOYMENT OF
LEGAL COUNSEL FOR THE
VILLAGE OF BARNESVILLE, OHIO
AND DECLARING AN EMERGENCY**

**BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BARNESVILLE,
STATE OF OHIO:**

Section 1. That Richard A. Myser, of Myser and Myser, be and he is hereby employed as legal counsel and solicitor of the Village of Barnesville, Ohio, for the period November 20, 2025, to November 20, 2027.

Section 2. That the compensation for all ordinary services, including attendance at two council meetings per month, rendered as such legal counsel and solicitor of said Village, shall be Twenty Thousand Dollars (\$20,000.00) per annum, payable monthly.

Section 3. That it shall be the duty of such solicitor to prepare ordinances, to act as attorney and counsel for the Village and the officers thereof in their official capacity, and, as such attorney, to render legal opinions to the Council and to any department or officer of the Village upon request.

Section 4. That this Resolution be and the same is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the said Village and shall be in full force and effect from and after passage and approval of same.
