**A RESOLUTION SUPPORTING THE OHIO COMMISSION
FOR THE UNITED STATES SEMIQUINCENTENNIAL (AMERICA250-OH)
AND DECLARING AN EMERGENCY**

WHEREAS, the Ohio legislature and the Governor created AMERICA250-OH in 2021 to plan, encourage, develop and coordinate the commemoration of the 250th anniversary of the United States and Ohio's integral role in that event and the role of its people on the nation's past, present and future; and

WHEREAS, AMERICA250-OH hopes to engage ALL Ohioans and ALL 88 counties through their many signatures and officially recognized programs, projects and events over the next several years by inspiring future leaders and celebrating all Ohioans' contributions to the nation over the last 250 years; and

WHEREAS, by adoption of AMERICA250-OH Resolution, we hope to educate, preserve, innovate, and celebrate.

NOW THEREFORE, BE IT RESOLVED by Council of the Village of Barnesville that:

Section 1. The Village of Barnesville hereby endorses AMERICA250-OH and their mission to educate, preserve, innovate, and celebrate EVERY Ohioan in EVERY county.

Section 2. A copy of this Resolution will be sent to the Municipal legislative delegation and AMERICA250-OH Commission.

Section 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety of the residents of the Village of Barnesville in order to celebrate and coordinate the commemoration of the 250th anniversary of the United States.

RESOLUTION NO. 4038

**A RESOLUTION AUTHORIZING THE MAYOR OF THE VILLAGE
OF BARNESVILLE TO ENTER INTO AN ANNEXATION
AGREEMENT WITH THE WARREN TOWNSHIP
TRUSTEES TO ANNEX 9.443 ACRES INTO THE VILLAGE OF
BARNESVILLE AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Barnesville, Ohio is desirous of annexing 9.443 acres of real estate into its corporate limits as described in Exhibit A attached hereto; and

WHEREAS, in accordance with Ohio Revised Code §709.192 the Village must first enter into an Annexation Agreement with the Warren Township Board of Trustees approving such annexation.

NOW, THEREFORE, be it resolved by the Council of the Village of Barnesville that the Mayor is hereby authorized to enter into an Annexation Agreement with the Warren Township Board of Trustees pursuant to Ohio Revised Code §709.192 to complete the annexation of the said 9.443 acre tract.

Section 1: That the Mayor is authorized to enter into an Annexation Agreement with Warren Township Trustees to annex 9.443 acres into the Village of Barnesville.

Section 2: That this Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and such that Council for the Village of Barnesville to enter into an Annexation Agreement with Warren Township to annex 9.443 acres into said Village.

Section 3: This Resolution shall take effect and be in force from and after the earliest period allowed by the law.
